Ordering Process

- ❖ *Employees are eligible to order new prescription safety eyewear once every two years.*
- ❖ ***Please take this information and the pre-printed order form to an Ophthalmologist, Optician, Optometrist or Optical technician of your choice.***
- ❖ *If your prescription is less than 19 months old you can order safety eyewear without a new eye examination. If your prescription is more than 19 months old, you will be required to have an eye examination at your expense.*
- ❖ *Employees should check the pricing of examinations and dispensing fee's prior to selecting an eye care professional*
- ❖ *Based on the instructions below, the optical professional will complete the order form and send to an Essilor PSE manufacturing facility.*
- ❖ *When the safety eyewear is completed, they will be shipped back to the optical professional for fitting and dispensing. You will need to return to the optical professional for the fitting. You will be responsible to pay for examinations, and/or dispensing services.*

Dear Optical Professional,

AIM NationalLease employees are required to wear ANSI Z87 approved safety eyewear at all times while working.

This AIM NationalLease employee has chosen you to be the examining or dispensing professional for their prescription safety eyewear. Please complete the appropriate section of the RX form that they have provided, paying special attention to PD's, Seg. Heights, lens types and lens materials. The choice of lens material and type should be made based upon your professional judgment, taking into consideration what the material is most suited for that individual's work environment.

The lenses that are allowed are as follows:

Single Vision, Bifocal-Round, D28, D35; Trifocal 7x28, 8x35

****Occupational DD28 and Premium Progressives are the responsibility of the employee to pay.***

Please note that all Occupational (dual seg) lenses require both a lower and upper add power.

**Examination or dispensing fees are the responsibility of the employee to pay.*
